

Anytime Fitness Transformation Challenge

Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility:

Anytime Fitness Transformation Challenge Sweepstakes (the "Sweepstakes") is open only to legal residents of Canada who have reached the age of majority in their province or territory of residence at the time of entry. To be declared a winner, selected entrants must correctly answer a time limited mathematical skill testing question without assistance. Employees of AF National LTD. (the "Sponsor"), Anytime Fitness Canada, Anytime Fitness franchisees, Anytime SEO Corporation. (the "Administrator"), and their respective parent, affiliate, and related companies, as well as the immediate family members (spouse, parents, siblings, and children) and household members of each such employee, are not eligible to enter or win. How to Enter:

Entrants can receive entries by participating in the Transformation Challenge and posting content on Instagram or by mail.

Method 1 – This entry method is only available to Anytime Fitness members who joined the Anytime Fitness Transformation Challenge can post content on Instagram:

Prizes will be awarded by random drawing, and an entrant's physical transformation resulting from their participation in the Transformation Challenge has no impact on the chance of winning a prize.

Complete the following requirements and abide by all of the social post requirements and content restrictions:

Instagram Entry Requirements:

Method 2 – Enter by Mail

To enter without becoming an Anytime Fitness member and without joining the Transformation Challenge, print your name, address, phone number, email address, and date of birth on a piece of paper and mail it in an envelope with proper postage to:

All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed proof of receipt by the Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected, or postage due entries, which will be disqualified.

Limit: up to 10 envelopes for a total of 10 Sweepstakes entries.

Entry Limits:

Mail-in entries will receive the same number of entries as Instagram entries, with one (1) entry awarded for each eligible mail-in submission, subject to the stated entry limits.

You may receive up to ten entries during the Promotion Period by any combination of entry methods described above. Multiple entrants are not permitted to share the same email address. Total ARV:

The total ARV of all available prizes offered in the Sweepstakes is \$17,037.44 CAD.

Odds of Winning:

Odds of winning depend on the total number of eligible entries received during the Promotion Period.

Additional Prize Terms:

Prizes must be accepted as awarded and are not transferable or exchangeable for cash, except at the Sponsor's sole discretion. If a prize, or any portion of a prize, cannot be awarded as described for any reason, the Sponsor reserves the right to substitute a prize or portion thereof of equal or greater value. Release:

General Conditions:**Sponsor's Right to Modify or Cancel:**

The Sponsor reserves the right to cancel, suspend, and or modify the Sweepstakes, including the fulfillment of any prize, if any of the following issues occur:

- Fraud;
- Technical failures;
- Human error;
- Any other factor that impairs the integrity or proper functioning of the Sweepstakes
- Any event or cause beyond the Sponsor's reasonable control, including natural disasters, national emergencies, widespread illnesses, declarations of war, acts of terrorism, or other force majeure events, as determined by the Sponsor in its sole discretion

Sponsor's Right to Disqualify Entrants:
